Set-up and Break-down Exceptions:

An Exhibitor/Vendor is not required to stop vending, during the hours prior to the Official Event Start Time or after the Official Event End Time. The exception is that all activity must cease, and the Exhibitor/Vendor must be packed up and ready to go at the Streets opening Time, 11:00 PM on Saturday, June 9, 2018.

Contracted Rates are for Saturday, June 9, 2018. Rain or Shine. There are no hourly vending fees.

You the Exhibitor/Vendor Must Supply Your Own Generator

Generators are primarily limited to perimeter spaces. Generators are the ONLY EXCEPTION to the rule governing the keeping of all items within your contracted spaces. For safety, the generator ONLY may be placed on the contracted rear space border, in perimeter spaces, in order to direct exhaust away from your vending space. Nothing else may protrude from your contracted space.

We the Exhibitor/Vendor agree to abide by the following rules and stipulations:

- 1. The Exhibitor/Vendor must provide your own insurance, as well as, having all permits required by Louisville Metro and the Commonwealth of Kentucky.
- 2. The Exhibitor/Vendor assumes all risk and hazard incident to the festival, your own exhibit/venue or to the Exhibitor/Vendors and representatives, or to any other persons in or around your exhibit/vendor area.
- 3. The Exhibitor/Vendor is responsible for the safety and cleanliness of your contracted spaces.

- 4. The Exhibitor/Vendor is required to supply your own tables, chairs, tents, awnings, extension cord, trash containers and all other items required or desired in the conduct of your business.
- 5. The Exhibitor/Vendor utilizing your own generators, are restricted to perimeter spaces for safety and because of noise. Generators are the ONLY EXCEPTION to the rule governing the keeping of all items within your contracted spaces. Nothing besides the generator may be placed on the rear border outside your contracted space.
- 6. Off Street Parking is available, at your own risk, for the Exhibitor/Vendor. ₹Patchwork Enterprises Inc., ₹Zion Baptist Church, Inc. and their parent companies, or affiliates, is not responsible for any hazards, damage, theft, vandalism, or any acts of God for or to vehicles, conveyances, goods, persons, etc. pertaining to the Exhibitor/Vendor.
- 7. Every Exhibitor/Vendor located on the Stage Lot will turn down or off any source of loud noise, during performances on the stage. Business can still be quietly conducted as long as it does not distract from the stage presentations.
- 8. Music may be played in the Exhibitor/Vendor area, as long as it is not excessively loud, and does not interfere with the Exhibitor/Vendor on each side of you.
- 9. Music will not have any offensive language or symbols, in the lyrics being played or on the face of the Album, CD, or DVD being sold.
- 10. Clothing of any type will not have offensive language or symbols displayed on it.
- 11. Albums, CDs, DVDs, are not to be sold that are considered "Bootleg" or "Pirated".
- 12. Clothing, including, purses that are NOT genuine designer articles, will not be sold as such, and will be posted conspicuously in the Exhibitor/Vendor space, that they are copies or duplicates by each vendor selling such.
- 13. There are NO REFUNDS past the stated date for such. There is no alternate 'Rain Date'. The Exhibitor/Vendor shall govern yourselves accordingly.
- 14. All Exhibitor/Vendor equipment, must fit completely within the dimensions of the space contracted. Your business must be conducted, within your contracted space. Larger Sizes are available, purchase what you need. You may not encroach into another Exhibitor/Vendor area nor in any area not contracted by you.
- 15. Once a space has been contracted, the only way to purchase additional space is to contract for, a new additional space, dependent on availability. Because of space assignments, there are no sizing upgrades to a previous contract.
- 16. No vehicles will be allowed to drive, nor trailers to be pushed around, within the Event area, accept during setup & breakdown times. If you do not arrive in time to setup before the Official Event Start Times, listed on this contract and in the Event Flyers, you may setup by walking your goods, to your location. If you leave prior to the Official Event End Time, you may walk your goods from your location to your conveyance.
- 17. Violations of these stipulations will be grounds for forfeiture of Exhibitor/Vendor contracted fees, right to vend or exhibit, and cause for immediate expulsion of the Exhibitor/Vendor. Any and all cost associated with perfecting this contract will be borne by the Exhibitor/Vendor, including any and all reasonable attorney fees, court cost, arbitration cost or any other expenditures arising out of carrying out the intent of this contract.
- 18. To the extent of its fault or strict liability Patchwork Enterprises Inc., Zion Baptist Church, Inc. and their parent companies, or affiliates: You will release, indemnify, defend, protect, and hold each of them, their affiliates, and their respective officers, directors, employees or volunteers, harmless from losses, costs (including all attorney fees and court and/or arbitration costs, litigations), expenses, claims, demands, liabilities and causes of action of every type and character arising out of the Agreement for personal injury, illness or death or loss thereof or damage to property, use of vending spaces, acts of God, riot, civil or criminal disruptions of the peace, robbery, gang activity, loss of, or potential loss of revenue, war, terrorism, and all other occurrences not specifically stated anticipated or unanticipated herein.

The Closing Date for submissions of Applications consisting of the <u>Contract</u>, a <u>picture of your vending goods</u> & <u>Full Payments</u>, for Exhibitor/Vendor Sites is MAY 28, 2018. Payments may be made by Check, Cash, Credit/Debit or U.S. Postal Money Order. Applications will NOT be accepted, after May 28, 2018.

For your protection all Credit and Debit Card transactions must be done in person and signed.

There will be no Refunds provided after Friday, MAY 21, 2018. If a cancellation and refund request is presented prior to MAY 21, 2018 a Refund will be issued less a 20% administrative fee. An Exhibitor/Vendor not accepted for the festival, will be notified JUNE 3, 2018 by telephone or email. You will be refunded your total contracted fee, and have your refund mailed to the address provided on your application make sure its correct. ALL refunds issued within 30 days after the end of the festival. No Refunds for Expulsion.
